Contestants must wear closed toe shoes, long pants and long sleeve shirts. Protective helmets and vests will be provided and must be worn by all contestants. You may provide your own, as well as mouth guards. Parents may accompany the child to the gate near the chutes. **There are absolutely NO ropes or spurs allowed. Parents may NOT accompany their child in the arena.** Each child will receive a prize from Rodeo De Santa Fe at the time they ride. If a child decides not to ride once he or she has paid the registration fee, there will be no refunds made. There are **NO re-rides** and the child must ride facing forward on sheep, No exceptions. **Rodeo tickets are NOT included in the entry fee.**

The undersigned hereby assumes all risks and hazards incidental to participation in all Rodeo De Santa Fe functions.
